Note from the Director



Coordinators (NCSWIC) Quarterly Newsletter. It was great to see so many SAFECOM and NCSWIC members at the biannual SAFECOM and NCSWIC meetings in Portland, Oregon, this past May. We discussed many important opportunities and challenges impacting the public safety community, including the role of cybersecurity and considerations for securing our public safety networks as technology advances. I appreciated hearing your perspectives as we continue to work together to ensure systems can integrate and information can flow securely and seamlessly as technology evolves.

In addition, I am pleased to introduce you to Mr. Vincent DeLaurentis, who assumed the duties of the Deputy Director for the Department of Homeland Security (DHS) Office of Emergency Communications (OEC) on April 30, 2018. Having served 30 years in the United States Coast Guard in a wide range of leadership positions, Mr. DeLaurentis has an extensive background in national emergency operations and incident management. He brings an operator's perspective to drive and promote communications for emergency responders and government officials to keep America safe, secure, and resilient. He commanded multiple Coast Guard cutters and planned, coordinated, and executed missions involving national security and emergency preparedness, and response and recovery missions. Please join me in welcoming Mr. DeLaurentis to OEC.

The third National Governors Association (NGA) Regional Workshop took place in Portland, Oregon, from May 16-17, 2018. This was the highest attended workshop thus far, convening eleven states: Arizona, California, Hawaii, Idaho, Louisiana, North Dakota, Oregon, South Dakota, Utah, Washington, and Wyoming. There was full participation by Statewide Interoperability Coordinators (SWICs) and increased participation of 911 representatives,

Chief Information Office staff, and Single Points of Contact (SPOCs) to ensure holistic planning for statewide governance. States developed action plans, including identification of long-term funding for SWICs, SPOCs, Statewide Interoperability Governing Bodies (SIGBs); increased Next Generation 911 (NG911) planning; and identification of funding for land mobile radio (LMR). Participants valued the opportunity to network, share best practices and lessons learned, and spend focused time with their individual state teams to discuss how to enhance public safety communications governance.

As we prepare for the Northeast Workshops, I would like to share a few of the many outcomes realized thus far:

- During the Southeast Regional Workshop, Kansas developed legislation passed by both the House and the Senate. Governor Colyer signed the legislation on May 10, 2018, and it is being implemented by the SWIC.
- Missouri developed and began implementing a comprehensive action plan during the Southeast Regional Workshop.
- During the Northwest Regional Workshop, the Idaho State Representative recognized the value of having a fulltime SWIC to oversee emergency communications statewide.

In addition, some of the key themes and lessons learned include the need for better coordination with local public safety organizations, enhanced legislative support, increased SIGB participation across the full ecosystem, and the need to maintain momentum through changing administrations.

Twenty-six states have participated in the first three regional workshops, and we anticipate increasing the total number significantly with twenty-three states and territories participating in the upcoming Northeast Workshops in Philadelphia, Pennsylvania, from July 25-27, 2018.

Lastly, with the enactment of the FY18 budget, OEC is able to increase its support to the stakeholder community in several exciting ways, including:

- Nine new OEC Coordinators to increase capacity to provide technical assistance and regional support for our state, local, tribal, and territorial stakeholders;
- Additional resources for Communications Unit (COMU) trainers;
- Increased funding for technical assistance; and
- Resources for a second competitive round of Rural Emergency Medical Communications Demonstration Project grant funding

Now more than ever, it is critical we continue to build partnerships to prepare for evolving changes in emergency communications. As technology advances, so do the expectations of the public. Alerts and warnings, NG911, social media, and other technology developments allow communities to interact with public safety officials and receive information in new ways. While these emergency communication enhancements are critical to enabling public safety operations, integrating new capabilities with existing systems can lead to interoperability challenges.

To prepare for these advancements, we must continue to work together, share best practices, promote strengthened governance structures, and continue to expand our training capabilities among all relevant disciplines across the emergency communications ecosystem. This is achieved through collaboration among SAFECOM, NCSWIC, and OEC and I am proud of all of the great work you have accomplished thus far. I am excited to continue to work together to engage in forward-looking dialogue which advances interoperability and operability both now and for the future.

Keep up the great work and I look forward to seeing many of you in Philadelphia!



Note from the SAFECOM Chair

Key among SAFECOM's priorities remain the assessment and growth of SAFECOM's membership; emphasizing the value of optimal governance structures to enhance interoperability; supporting lifecycle funding guidance; communicating guidance and challenges associated with new and emerging technologies; providing guidance and best practices to sustain and support LMR; supporting the transition to NG911; supporting the

integration of information technology and communications in the National Incident Management System (NIMS); and the ongoing work to protect the T-Band frequencies.

My thanks to all who participated in and presented at our last biannual SAFECOM meeting, held in Portland, Oregon, in May. The Portland session was four meetings almost running concurrently at times. I wish to thank you for making all these sessions a success and promise we shall avoid, to the best of our collective abilities, overlapping meeting formats in the future. Members participated in many engaging sessions including emerging 5G technologies, the DHS Science and Technology Directorate projects, NGA Workshops accomplishments, and how modern cybersecurity threats have affected nearly every major industry. Members also received updates on the development efforts for the 2019 NECP and 2018 State, Local, Tribal, and Territorial (SLTT) Governance Guide. The SAFECOM Executive Committee (EC) also approved the following products:

- Request for Information (RFI) and Request for Proposal (RFP) for LMR Subscriber Units Roles and Responsibilities
- Inter-RF Subsystem Interface (ISSI) Fact Sheet

Each of the SAFECOM committees highlighted exciting work currently in development or planned for the coming year, and I thank you for your hard work and determination.

I would like to personally thank Ms. Jeanette Manfra, Assistant Secretary for the DHS Office of Cybersecurity and Communications, who delivered a keynote presentation focused on reducing cyber risk through increased coordination among stakeholders and decision makers. Ms. Manfra emphasized her support and acknowledgement of SAFECOM's role in guiding the country toward secure, interoperable solutions by working across multiple sectors, such as information technology, energy, financial, and transportation. The Assistant Secretary also encouraged SAFECOM to consider the vast amounts of data being exchanged and the need for more sophisticated thinking when it comes to how responders use and manage information; the increased connectivity of our devices, apps, and systems; and the unique threats we face due to data and interconnectivity. SAFECOM and our partners can and must continue to guide the community to success by adjusting programs and training, identifying alternate funding sources, developing new Standard Operating Procedure (SOP)-based lessons learned from real-world experiences, integrating technology, and supporting robust yet flexible governance structures.

We have made great strides in many of these areas already and will remain dedicated to implementing a national vision of interoperability for the public safety community. Meet the Stakeholders

Greg Hauser

NCSWIC, North Carolina Statewide Interoperability Coordinator (SWIC)

Greg Hauser was hired by the North Carolina Division of Emergency Management (NCEM) on April 9, 2018, to serve as the state's SWIC. Greg is also the state's Communications Branch Manager and the point person for Emergency Support Function (ESF)-2 (ESF2) activities, alerts and warnings, and tactical communications team training, readiness, and mobilization. Prior to joining NCEM, Greg spent 17 years with the Charlotte Fire Department's Communications Division, beginning as a telecommunicator and eventually serving as the Superintendent of the

Communications Division. Greg proposed and created the division's tactical communications team comprised of four vehicles and multiple division personnel, which deploys with the North Carolina Urban Search and Rescue (USAR) assets and as a resource to local jurisdictions. With the Charlotte Fire Department, Greg served as the Charlotte Urban Area Security Initiative (UASI) Tactical Interoperable Communications Planning (TICP) manager, Chairman of the Regional Communications Council, Chairman of the North Carolina Statewide Interoperability Executive Committee (SIEC), and, most recently, a member of the North Carolina 911 Board representing the North Carolina State Firefighters' Association.

Greg has been a part of numerous large-scale incidents and events, including the Communications Unit Leader (COML) assignment for the 2012 Democratic National Convention, Hurricane Irene, and Hurricane Matthew. In his part-time career, Greg served as a subject matter expert for the Interoperable Communications Technical Assistance Program (ICTAP) and assisted states with large event communications planning, exercise design and facilitation, and other duties.

Greg is originally from Becket, Massachusetts, and attended the University of New Haven in Connecticut where he earned Bachelor's Degrees in both Fire Investigation and Fire Administration. 2018 SLTT Governance Guide Meetings

On March 29, April 12, May 3, and May 24, OEC hosted meetings with the SLTT Governance Guide Working Group in preparation for updating the SLTT Governance Guide. The working group is comprised of stakeholders from SAFECOM, NCSWIC, and tribal entities. During the meetings, working group members appointed a Chair and Vice Chair to help guide future efforts and began the process of conducting an in depth review and revision process. OEC Expanding Understanding of Tribal Public Safety Communications and Governance

OEC coordinated with the NCAI to support a tribal emergency communications panel discussion at the Joint SAFECOM NCSWIC meeting held in Norman, Oklahoma, on November 7, 2017. This was the first joint SAFECOM NCSWIC tribal-focused panel and it provided an opportunity for members to learn about key tribal communications activities and challenges. OEC is also continuing efforts to establish and build collaborative relationships with federally recognized tribes through the Tribal Emergency Communications Governance Profile effort. This effort is building OEC's understanding of tribal emergency communications operations, resources, and interoperable emergency challenges, which helps OEC to identify opportunities to assist tribes with assessing and improving their unique operable and interoperable communications capabilities.

Resources on Broadband Deployment in Rural Communities

In an effort to consolidate information regarding broadband deployment across the United States into a consolidated, one-stop information sharing website, the National Telecommunications and Information Administration (NTIA) has implemented the <u>BroadbandUSA program</u>. This program promotes innovation and economic growth by supporting efforts to expand broadband connectivity and meaningful use across America.

Release of FY 2018 SAFECOM Guidance on Emergency Communications Grants

OEC announced the <u>Fiscal Year 2018 SAFECOM Guidance</u> <u>on Emergency Communications Grants</u> (SAFECOM Guidance). This document is updated annually to provide current information on emergency communications policies, eligible costs, best practices, and technical standards for state, local, tribal, and territorial grantees investing federal funds in emergency communications projects.

<u>List of Federal Financial Assistance Programs for</u> <u>Emergency Communications Funding</u>

Following the release of the FY 2018 Consolidated Appropriations Act, DHS OEC and the Emergency Communications Preparedness Center (ECPC) Grants Focus Group worked with federal granting agencies to update the FY 2018 List of Federal Financial Assistance Programs Funding for Emergency Communications Federal Funding Opportunities. This list includes program descriptions, available funding amounts, application deadlines, and links to federal agency websites for additional information.
